



**Invitation to Bid No. 19-05-12**

**PROCUREMENT OF APPLIANCES, EQUIPMENT AND VARIOUS SUPPLIES**

1. The West Visayas State University, through the Special Trust Fund and GAA 2019 intends to apply the sum of Two Million Nine Hundred Twenty Seven Thousand Eight Hundred Eighty Five Pesos and 63/100 Centavos (PhP2,927,885.63) Only being the Approved Budget for the Contract (ABC), to payment under the contract for Procurement of Appliances, Equipment and Various Supplies. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening, broken down as follows:

2. The West Visayas State University now invites bids for Procurement of Appliances, Equipment and Various Supplies. Delivery of the Goods is required for thirty (30) calendar days. Bidders should have completed, within two (2) years from the date of submission and receipts of bids, a contract similar to Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the office of the BAC Secretariat and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on May 24 – June 18, 2019 from 8:00 A.M. – 5:00 P.M. at the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Four Thousand Pesos (PhP4,000.00) Only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The West Visayas State University will hold a Pre-Bid Conference on June 04, 2019, 10:00 A.M. at BAC Secretariat Office, Administration Building, WVSU Main Campus, La Paz, Iloilo City which shall be open to prospective bidders.
