




Invitation to Bid No. 19-11-42

REHABILITATION OF CICT BUILDING ELECTRICAL SYSTEM (RE-BIDDING)

1. The **West Visayas State University**, through **Special Trust Fund 2019 (unprogrammed)** intends to apply the sum of **Three Million One Hundred Thousand Pesos (PhP3,100,000.00) Only** being the Approved Budget for the Contract (ABC) to payments under the contract for **Rehabilitation of CICT Building Electrical System (Re-bidding)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **West Visayas State University** now invites bids for **Rehabilitation of CICT Building Electrical System (Re-bidding)**. Completion of the Works is required for **sixty (60) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the office of the **BAC Secretariat** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 27 – December 16, 2019** from **8:00 A.M. to 5:00 P.M.** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP5,000.00) Only**.
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **West Visayas State University** will hold a Pre-Bid Conference on **December 04, 2019, 10:00 A.M. at BAC Secretariat Office, Administration Building, WVSU Main Campus, La Paz, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or **before 2:00 P.M. on December 17, 2019**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
Bid opening shall be on **December 17, 2019, 2:00 P.M. at BAC Secretariat Office, Administration Building, WVSU Main Campus, Luna Street, La Paz, Iloilo City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **West Visayas State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
