CONTRACT AGREEMENT

No. 2021-02-03

THIS AGREEMENT made the 18th day of OCTOBER 2021 between **WEST VISAYAS STATE UNIVERSITY – JANIUAY CAMPUS**, Janiuay, Iloilo of the Philippines (hereinafter called "the Entity") of the one part and **THREE N' ONE ENTERPRISES** of 1st Lawaan Village, Balantang, Jaro, Iloilo City (hereinafter called "the Supplier") of the other part;


