## INVITATION TO BID FOR <u>PROCUREMENT OF SECURITY SERVICES</u> <u>IB No. 2022-01</u>

- 1. The <u>West Visayas State University Janiuay Campus</u>, through the <u>Fund 164 and NEP 2022</u> intends to apply the sum of <u>Eight Hundred Fifty-Two Thousand Three Hundred Eighty-Eight Pesos and 20/100 (PhP852,388.20) Only</u> being the ABC to payments under the contract for <u>Procurement of Security Services</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The <u>West Visayas State University Janiuay Campus</u> now invites bids for the above Procurement Project. Delivery of the Goods is required by <u>January 01 to December 31</u>, <u>2022</u>. Bidders should have completed, within <u>2 years</u> from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from <u>West Visayas State University</u> <u>Janiuay Campus</u>, and inspect the Bidding Documents at the address given below during 8:00 A.M. 5:00 P.M.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>October 27</u>
  <u>- November 17, 2021</u> from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php1,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The <u>West Visayas State University Janiuay Campus</u> will hold a Pre-Bid Conference<sup>1</sup> on <u>November 05, 2021; 10:00 A.M.</u> through video conferencing or webcasting via <u>google meet/zoom (for registration of interested bidders, please send your request to this address: <u>mis.jc@wvsu.edu.ph</u>), which shall be open to prospective bidders.</u>
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before *November 17*, 2021; 10:00 A.M. Late bids shall not be accepted.

For **online or electronic submission**, bid proposals will only be submitted once.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on <u>November 17, 2021; 10:00 A.M.</u> at the given <u>address below or</u> through <u>electronic submission using a two-factor security procedure consisting of an archive format compression and password protection with separate password for technical <u>and financial component envelope</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.</u>
- 10. Requiring the Bidders to submit their bids using a two-factor security procedure consisting of an archive format compression and password protection with separate password for technical and financial component envelope and disclose the password for accessing their respective bid submission only during the actual bid opening.
- 11. The <u>West Visayas State University Janiuay Campus</u> reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
- 12. Only one (1) representative per bidder will be allowed to attend the bid opening. Health and safety protocols like wearing of face mask and physical distancing will be strictly observed.
