



Invitation to Bid No. IB2024-04

CONSTRUCTION OF STUDY SHED & IMPROVEMENT OF LAGOON (RE-BIDDING #2)
ABC: Php 999,955.15

1. The **West Visayas State University-Lambunao Campus**, through its **FUND 164 (INCOME)**, intends to apply the sum of **NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED FIFTY-FIVE PESOS & FIFTEEN CENTAVOS ONLY (Php 999,955.15)** payments under the contract for **CONSTRUCTION OF STUDY SHED & IMPROVEMENT OF LAGOON**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **West Visayas State University-Lambunao Campus** now invites bids for the above Project. Completion of the work is required **Thirty-five (35) Calendar Days (CD)**. Bidders should have completed within two (2) years a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least Sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA5183.

4. A complete set of Bidding Documents may be acquired by interested Bidders on **June 11-July 01, 2024** from **8:00 A.M. to 5:00 P.M. only** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **ONE THOUSAND PESOS (Php1,000.00) ONLY**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The West Visayas State University-Lambunao Campus will hold a **Pre-Bid Conference on June 19, 2024, 8:00 A.M.** at the **WVSU-LC Finance Office, 1st Floor Administration Building, Lambunao, Iloilo** which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or **before 8:00 A.M. on July 01, 2024**. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
8. Bid opening shall be on **July 01, 2024, 8:00 A.M. at WVSU -Lambunao Campus, Finance Office 1st Floor Administration Building**. Bids will be open in the presence of the bidder's representatives who choose to attend the activity.
9. The **West Visayas State University-Lambunao Campus** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
