REQUEST FOR EXPRESSION OF INTEREST NO. 2022-01

PROCUREMENT OF CONSULTING SERVICES FOR THE GEORESISTIVITY SURVEY FOR THE GROUND WATER SOURCE DEVELOPMENT OF WVSU LAMBUNAO CAMPUS (RE-BIDDING)

1. The West Visayas State University, through the Fund 164 intends to apply the sum of THREE HUNDRED THOUSAND PESOS (Php 300,000.00) ONLY being the Approved Budget for the Contract (ABC), to payment under the contract for Procurement of Consulting Services for the Georesistivity Survey for the Ground Water Source Development of WVSU-Lambunao Campus (Re-bidding). Proposals received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The West Visayas State University-Lambunao Campus now calls for the submission of eligibility documents for Procurement of Consulting Services for the Georesistivity Survey for the Ground Water Source Development of WVSU-Lambunao Campus (Re-bidding). Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before June 22, 2022; 9:00 A.M. at the BAC Secretariat Office, WVSU Lambunao Campus, Lambunao, Iloilo or through electronic submission (via gmail address: bac.lambunao@wvsu.edu.ph) consisting of an archive format compression and password protection. Applications for eligibility will be evaluated based on a discretionary "pass/ fail" criterion.
3. Interested Consulting Firms may obtain further information from BAC Secretariat Office, WVSU Lambunao Campus, Lambunao, Iloilo and inspect the Bidding Documents at the address given below during 8:00 A.M. – 5:00 P.M. A complete set of Bidding Documents may be acquired by interested Consulting Firms on June 14 - 22, 2022 not later than the deadline/submission of proposals from the address below, in the amount of Five Hundred Pesos (PhP500.00) Only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that **Consultants** shall pay the applicable fee for the Bidding Documents not later than the submission of their proposals.

4. The WVSU-Lambunao-Campus will hold a virtual/face to face Pre-Bid Conference on June 27, 2022, 9:00 AM, at the AVR Building, WVSU-Lambunao Campus which shall open to all interested parties with written authorization letter from their principals. The WVSU-LC BAC will be using zoom (Meeting ID: 561 206 1321; Passcode: WVSULCBAC) as the platform. A bidder shall submit a letter in advance, addressed to the WVSU-LC BAC Chairperson via electronic mail through bac.lambunao@wvsu.edu.ph containing the name, email address, and contact number of its authorized representative/s, and in certifying that said representative/s has/have authority to speak for and in behalf of the Consultant.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) to five (5) prospective consultants who will be entitled to submit proposals. Should only one (1) or less than the required number apply for eligibility and short listing pass the eligibility check, and/or pass the minimum score required in the short listing, the BAC shall consider the same. The criteria and rating system for short listing are:




