We are pleased to inform you that the **West Visayas State University (WVSU)** is **ELIGIBLE** for the grant of Performance-Based Bonus (PBB) for Fiscal Year 2017. However, considering that WVSU has one (1) unmet target due to controllable factors, the unit/s most responsible for the agency's non-attainment of the target for **PI 3 under MFO 3** should be **isolated and excluded** from the FY 2017 PBB ranking. The summary of the final IATF assessment result is attached.

To complete the PBB process, may we remind your office to publish the WVSU MFO Accountability Report Card (MARC-1) and Management Accountability Report Card (MARC-2) in your website or official publication. Please coordinate with the AO 25 Technical Secretariat for the finalization of the said report cards.

Furthermore, please be advised that the evaluation of agency accomplishments for FY 2018 shall be tightened in accordance to strengthening the performance of agencies, particularly in shifting the focus on performance information at the program level and the monitoring and assessment of each strategic priority program's outcome and output indicators. All agencies are apprised to take actions in accelerating procurement and timely utilization of approved budgets to properly support their operations and delivery of high quality services.

	 Did not meet the 100% targets for Obligations and Disbursements BUR under GASS. Actual accomplishments were 99.71% and 92.07%, respectively.
	 The justifications provided by WVSU for not meeting its targets for Obligations and Disbursements BUR were considered to be due to uncontrollable factors based on DBM- RO 6 report dated 3/27/2018.
OVERALL ASSESSMENT	 Based on the results of validation, WVSU satisfied the requirements and is eligible for the grant of FY 2017 PBB. However, the unit/s (including the highest ranking official) most responsible for the university's non-attainment of the target for PI 3 under MFO 3 should be isolated and excluded from the FY 2017 PBB ranking.
